Thank you for participating in the 11th celebration of International Flavors of Marina to be held Thursday, April 4th, 2019, from 5:30 to 8:30 p.m. at SpringHill Suites by Marriott, 215 10th St, Marina. **To reserve your FREE exhibit space at International Flavors of Marina, please read, sign and return this agreement by March 15th, 2019.** Exhibit space is available on the first-come, first-serve basis, so sign up early!

1. On April 4th please arrive with your product at the SpringHill Suites between 4:00 and 4:30 p.m.
2. Your participation includes two “All Access” server passes which will be provided when you arrive.
3. Your table **MUST** have at least one server present for the entire event. Those serving alcohol must have at least one server trained and knowledgeable about the responsible serving of alcohol.
4. One six-foot display table will be provided for food servers, wineries, and breweries.
5. Standard tables do not include electricity.
6. Supplied by PARTICIPANT:
 - Signed Flavors Participation Agreement and completed Marina Chamber Insurance Agreement
 - Product samples to serve approximately 350 people (hors d’oeuvres sized). Booths shall remain fully staffed and prepared to serve attendees from 5:30 to 8:30 p.m.
 - Heating and serving equipment, serving trays, serving utensils, and utensil sanitizing station
 - Chilling equipment or ice, pour bucket, water if needed
 - Creative and festive table decorations are highly encouraged (no hanging or standing decorations please).
 - Business cards and menus for distribution and promotion of your business are encouraged.
7. Supplied by MARINA CHAMBER:
 - Table, tablecloth and a sign with your business name.
 - Wine glasses, cups, plates, eating utensils, napkins (100% compostable—do not bring plastic).
8. Each participating business **MUST** keep its table clean during the event and clear all product materials when the event ends.
9. By signing the Agreement and providing Chamber Insurance Requirements, you are responsible for your products and servers and relieve the Marina Chamber of Commerce of any responsibility other than providing the venue.
